



Minutes of the WRRC General Meeting March 13th, 2022, Helsinki, Finland

Start of the meeting: Sunday, March 13th, 2022 at 09:30

ITEM 1 Welcome by the President and definition of formalities

The President, Miriam Kerpan Izak, welcomed all delegates, officials, auditors and opened the meeting

The President confirmed that the General Meeting had been duly convened and was quorate. There were **30 delegates/proxies** from 16 countries present at the meeting, (**27 delegates from the ordinary members** with the right to vote, and **3 proxy delegates from the ordinary members** with the right to vote). For the simple majority, 16 votes were needed, for the 2/3 majority 20 votes were needed.

The President proposed to use electronic voting during the GM, over the platform MentiMeter, and proposed Kresimir Bosnar and Bartlomiej Kobylanski as the scrutineers for the e-voting.

The finance director, Marina Eskolin, gave some additional explanations regarding the budget, which was prepared and sent to all delegates prior to the situation in Ukraine. The situation will affect also the financial situation of the WRRC, because of the cancellation of competitions in Russian Federation, as well as ban of the competitors from Russia.

Following the happenings in Ukraine, WRRC Presidium decided not to use the money from the Russian sponsors which was already received. This money will be stored on the separate account, and it will not be transferred anywhere. This also means that we will have to find some other sources of income for the future.

ITEM 10 PRESIDIUUM MOTIONS

Motions were presented to the delegates by the Vicepresident for Legal Affairs, Patrice de la Torre.

Presidium motion P03: Tournament Fee for RR MCFS

The Presidium proposed the option to financially support one couple of the Rock'n'Roll Main Class Free style per participating nation. The Prize money would be paid by WRRC to the best couple of each participating country on each World Cup, based on the final results, which would be financed by increasing the World Cup Tournament fee to 3.000 EUR.

In a following discussion it was clear, that the delegates were not in favour of rising the competition fees. Sophie Sancosme (SUI) stressed out, that it is already a challenge to organize the World Cup for the Main Class Free Style, and that the number of the MCFS couples is decreasing.

The Presidium accepted the arguments of the delegates, and withdrew the motion. There was no voting on this motion.

ITEM 11 – MEMBERS MOTIONS

All motions were sent to the members and delegates in due time, and will be published on the WRRRC website, together with the minutes. Therefore, they will not be repeated here in details.

M1.1 to M1.2 Finland, 2 motions

Motions were presented by Pirjo Koivula:

- **Motion 1.1:** Change of Statute, by establishment of the Sports Director for Boogie Woogie. The motion was aimed at equal consideration of the sporting matters and equal representation of the disciplines Boogie Woogie and Rock'n'Roll in the WRRRC Presidium.

Sports Director, Denis Lilih, explained that Marina Eskolin already is a member of the Boogie Woogie Commission, as representative of the WRRRC Presidium, and the Presidium is equally informed about the topics discussed in both Sport Commission and Boogie Woogie Commission.

Katrin Kerber (Germany) asked about the position of the Boogie Woogie Commissioner (Aina Nygard) and her participation on the Presidium Meetings.

Miriam Kerpan Izak explained, that the Presidium discusses all materials of the Boogie Woogie Commission, presented by Marina Eskolin. The Boogie Woogie Commissioner is always invited to the Presidium meeting preceding each General Meeting.

The motion was withdrawn, because Motion 1.1 was not accepted. There was no voting on this motion

M2.1 to M2.7 Germany, 7 motions

Motions were presented by Katrin Kerber and Lukas Brauer:

- **Motion 2.1:** Indication of Observer's deduction in Final heat results

President Miriam Kerpan Izak pointed out, that there is already a Presidium decision nr. 350 (January 2022) to implement a similar solution: after the performance of each couple, on the screen, we will show the total recognized value of the announced acrobatics by the

observer, compared to the theoretical announced value of the acrobatic program (example: 61/65).

On questions from Igor Vinković (Croatia), Kresimir Bosnar explained that in all rounds preceding the final, scrutineers print out the special report where all deductions by the observer are visible for each acrobatic element.

During the following discussion, Sports Director and Kresimir Bosnar also explained the procedure of protesting against the decisions of the observers on the competition. Each protest must be given to the Supervisor, following the rules of the procedure (latest 10 minutes after publishing the results in the competition hall). This is especially important in the final rounds of RR Main Class Free Style and Main Class Contact Style when the Winner ceremony follows immediately after the round. We now have all the means to successfully check and eventually revise the decisions of the Observers (all rounds are recorded on the official Go-Pro camera of the WRRRC).

Following this discussion, Germany withdrew Motion 2.1

- **Motion 2.2:** Clarification on protest procedure on the competitions

Part of the discussion about Motion 2.1 also referred to the problems described in Motion 2.2. Following both discussions, the Sports Director proposed that the GM delegates this motion to the future Sport Commission, which should revise the Rules of the procedure of the protests on the competitions, as part of the big revision of the rules which is planned for 2022.

Germany accepted this proposal and withdrew the Motion. There was no voting on Motion 2.1

- **Motion 2.3:** Limitation of participants per nation in final rounds of international Championships (Continental or World Championships)

President Miriam Kerpan Izak expressed the opinion of the Presidium, which in general supports the idea of more diversity of nations in the finals, but also the concerns connected with the fact that it could favor the nations with a small number of participants, by granting them very high positions in the final result. We need to carefully decide all aspects of this proposal.

Germany accepted the arguments and amended the motion with the proposal to give the WRRRC Presidium the task to find the correct procedure for the limitation of the number of participants per nation in the semifinal and final rounds of the Championships.

- **Motion 2.4: Preservation and additional rating of Bettarini entrance. The execution of Bettarini should be made obligatory for all participants in heats starting from semifinals in Main Class categories**

Katalin Kis and Denis Lilih explained the opinion of the Presidium. This element is already protected in the RR MCCS with additional points as motivation to couples to perform this entrance. If it would be an obligatory element, then there is no reason to give it any additional points. On the other hand, if we introduce the additional points to the Main Class Free Style, some couples would have to reduce the level of their acrobatics, to stay within the limit of 65 points.

Sophie Sancosme (Switzerland) remarked, that the additional points for the Bettarini in the RR MCCS were introduced shortly before the COVID-19 outbreak and that until now we did not have a chance to properly evaluate the effects of this measure on the competitions. Without a proper evaluation, it would not be a good solution to introduce it as an obligatory element.

Sandro Spendier (Austria) expressed the opinion that the General Meeting is not the body that should discuss on such special topics, and that this question should be the task of the Sport Commission.

Germany accepted the arguments from the delegates, and amended the motion as proposed, to give the task to the Sport Commission.

President Miriam Kerpan Izak explained that such limitation is not in the Statute of the WRRC, because it would rule out the possibility to have proper discussions on any more complex questions which might be the topic of the General Meeting. The Presidium decides on the length of the discussions based on the number and complexity of the motions presented by the members.

President Miriam Kerpan Izak explained the Presidium opinion on the motion. At the beginning of each General Meeting, the delegates accept the Operating Policy proposed by the Presidium, which is again based on the topics and number of motions that will be discussed. The opinion of the Presidium is, that there is no need for a special person who would additionally take care of the length of the discussions. Such a person would also have to attend the Presidium meetings to coordinate all the discussions and tasks on the General Meeting. In the Statute of the WRRC, we have clear rules about the Chair of the General Meeting and eventual substitutions, in case the President of the Presidium cannot attend the GM.

She introduced each of the candidates by posing them some questions about their programs and plans for their work. Delegates voted electronically after each presentation of the candidate(s) for a particular function.

Auditors' Report on Financial Statements 2021

To the General Assembly of the World Rock'n'Roll Confederation, meeting in Helsinki.

We, the elected auditors of the World Rock'n'Roll Confederation ("WRRC"), have audited the Financial Statements of the WRRC consolidated on March 11 and 12, 2021 in Helsinki. Our responsibility is to express an opinion on the financial statements taken as a whole based on our audit work performed in accordance with the audit regulations in force in Austria, (§ 5 Abs. 5 Vereins - Gesetz 2002) which require examination, by means of selective tests, of the evidence supporting the financial statements and evaluation of whether their presentation, the accounting principles and policies applied and the estimates made comply with the applicable regulatory financial reporting framework.

The year 2021 was marked not only by Covid 19, but also by issues with the principal bank of the WRRC.

While the pandemics forced the WRRC to resort to online competitions, which resulted in significantly higher organization costs, the shift of the principal bank has complicated the treasurer's work and unfortunately resulted in markedly increased operating cost too.

The online competitions have obliged a large number of dancers to use the official WRRC Claim of expenses form for the first time. This led to the situation that these dancers, along with many officials who should have known better, submitted an important number of unsigned – and therefore in principle invalid – claims.

However, we the auditors, are really sick of criticizing this point of the missing signatures on the claims every year and therefore want to suggest to the Presidium to modify the form, omitting the signature. We have been assured by the Treasurer that all claims are always checked for their foundation (by means of the results from completions, or lists of participants at meetings) and therefore we must not fear that unsubstantiated claims would be paid out.

After several discussions with the Treasurer, we the auditors, have come to the conclusion that the accounts have been kept in accordance with the rules and represent the true financial situation of the WRRC as of December 31, 2021. We have checked that the accounting information in the report is consistent with that contained in the financial statements for 2021.

We, the auditors, commend the Treasurer for her clear operations.

We move to discharge the Financial Director, and the entire Presidium, for all the financial operations performed in 2021.

We the auditors Gritli Ramschag Wollein and Daniele Fuog, appreciate the trust that the General Assembly has put in us and would love to continue to carry out this task for one last term. We therefore stand for reelection.
