

# Minutes WRRC Presidium meeting,

Ljubljana, 06.03.20008 and 07.03.2008

The president welcomed all Presidium members for the meeting.

### Item 1 Approval of Agenda

(183) Agenda was approved without amendments

## Item 2 Approval of Minutes of last Presidium meeting Ljubljana 26/27.01.2008

- (184) Proposed changes of Fee Scale: We add the same prize money for Boogie formations as it is proposed for Rock'n'Roll formations
- (185) Naming of "B" class: After GM we will publish a forum or send our an email for proposals for new name RR "B" class

#### Item 3 Motion Jim Jackson

JJ presented a motion to organize an event in USA in 2009 or 2010. He wanted to know organizational and financial requirements for such an event. His wish was to present different WRRC disciplines in order to get more recognition in USA. We had not enough information to make a fixed decision

(186) Generally we agree with multi-event in USA. JJ prepares a concept for WRRC competitions in USA in 2009/2010. After the concept MKI will prepare a proposal following WRRC rules with minimal expenses.

## **Item 4** General meeting

We went through Agenda of GM weekend and details about announced activities. MKI informed everyone about the expenses settled by Rock'n'Roll federation from Slovenia (seminar rooms, dinner Friday, dinner Saturday).

#### Item 5 Members

We received an application from Poland to change the member federation from PTT to PZRA. We have received the statutes of new federation and explanation of Alec Nowak about the need for this change. Since the new federation doesn't include all active dancers from Poland and we have no information from responsible persons from PTT or from sport Ministry from Poland we can't make any final decision.

- (187) The Presidium confirmed approval of extraordinary membership for Bulgaria and Bosnia for 2008.
- (188) The Presidium can't change the member federation from Poland until we have more official data. We expect a letter from PTT, a letter from sport Ministry and guarantee that also boogie couples will be included in the new federation.

## Item 6 Commissions

#### **Formations**

New formation commissioner Dr. Robert Obermeier has presented himself and also his concept of work. We told him about his responsibilities and his connection with WRRC presidium. We pointed out the most important tasks for formations.

### **Boogie Woogie**

Tony Keller presented his report and we have also discussed the important topics about Boogie Woogie situation, especially about problems about acrobatics in Junior category. TK also informed us about a short guidelines which will be presented to all judges in the briefing before each competition.

(189) For Boogie Woogie Juniors a new limitation of figures is valid with immediate the same figure restriction as Rock'n'Roll youth.

### **Lindy Hop**

We had no meeting with Lindy Hop commissioner. We plan to do it on our next PM.

#### Item 7 Presentation Andreas Mack

Andreas Mack has presented a concept to organize workshops for dancers and trainers in order to pass his knowledge about the acrobatic training concept to other people. His presentation has included also a new idea of judging the acrobatics. The goal was to have the WRRC approval that these seminars will be organized under WRRC umbrella.

(190) WRRC is not an educational institution so we can't give anyone a "certificate" for organizing seminars. Different concepts are practiced in different countries so we can't just support one of them. WRRC has at the moment no new judging system, different concepts are still discussed.
