

Short Minutes - WRRC Presidium meeting

Budapest, May 22, 2022, 09:00 CET

1. Minutes from the last Presidium meeting

(24) Presidium accepted the short and long versions of the Minutes from the last Presidium meeting.

2. WRRC Commissions

- (25) The Sport Commission and the Boogie Woogie Commission already held their constitutional meetings. All other commissions (Judging Commission, Expansion Commission, Education Commission) must have their constitutional meeting latest until June 15, 2022.
- (26) VP for expansion and marketing is automatically a member of judging commission in order to implement a process for judges in new WRRC member countries
- (27) The Presidium dismissed the old Music Commission, and elected the new members of the Commission:
 - Denis Lilih
 - Patrice de la Torre
 - Attila Szakal
 - Krešimir Bosnar (WRRC Office, technical support of the commission,)

The Music commission should prepare clear guidelines about the structure and style of the music which will be used on the WRRC competitions, and which will apply to the individual music of couples/formations, and to the music prepared by the organizers of the competitions. The draft proposal should be presented at the Presidium meeting in August.

3. Sport topics

3.1. Boogie Woogie Rising Stars

(28) To achieve a good start for the Rising Stars category, the Presidium decided that there will be no limitation on how long couples can stay in this category. This decision will be re-evaluated in three years (2025). PdIT will prepare the new wording of this rule in the document "Rising Stars Boogie Woogie Regulation". The rule is valid immediately!



3.2. WRRC Judging Seminars

- (29) Regular WRRC Judging seminars for BW and RR will be organized two times a year, preferably on fixed days, with a minimum of 5 announced participants. Seminars can be organized also at the request of the individual persons, but all costs must be covered by the participant (seminar fees, remuneration for lecturers according to the fee scale).
- (30) According to decision 29, the next seminars for BW and for RR in this year will be organized in the second part of the year, and as online seminars. The dates will be published latest until the end of June.

3.3. Safety level 5 revision

(31) The Sport Commission will make a revision of the RR Safety Level 5, to avoid any confusion and different interpretations of existing regulations. PdIT will be present at this commission meeting.

3.4. Competitions

- (32) On competitions that span over two or more days, all dancers must have free access to the competition hall also on the day they are not competing. The document "Organization of WRRC Tournaments" will be adjusted accordingly (PdIT).
- (33) To avoid unnecessary crowds during the check-in (registration) of the couples/formations on the competitions, the Presidium will prepare special rules for this procedure (MKI and BK).

Until these rules will be prepared and published, the Presidium strongly recommends that each National Federation appoints only one person who will register all couples and formations of their federation.

The date of the next Presidium meeting was not decided.
